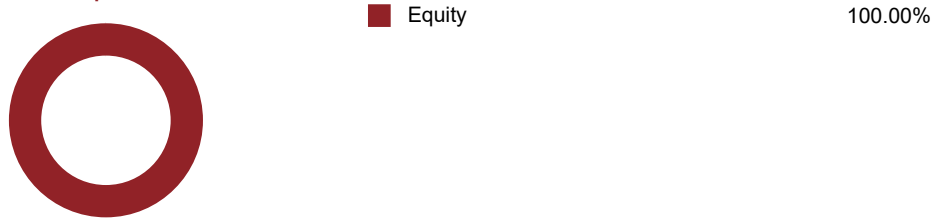
- The amount invested in company shares

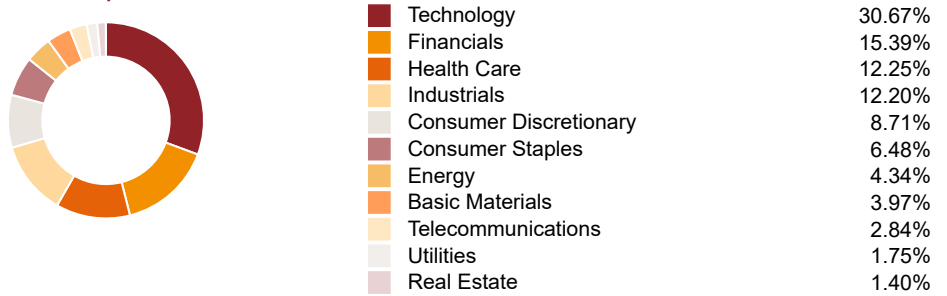
