BASF expands construction chemicals business to South China by acquiring Kejie's concrete admixture business

- BASF now active in concrete admixture business throughout China
- Broad customer portfolio in civil, commercial and residential construction

BASF Construction Chemicals (China) Co., Ltd. announced today (December 15, 2008) that it has acquired the concrete admixture business of Kejie Admixture Science & Technology Co. Ltd. ("Kejie"), a leading concrete admixture supplier in South China. Located close to Guangzhou, the capital of the Guangdong province, Kejie produces a wide range of concrete admixtures and intermediate products. Approximately 100 employees, including the management, are expected to join BASF as part of the transaction. Both parties agreed not to disclose any financial details of the transaction.

With the acquisition of Kejie's admixture business, BASF extends its production network capacity to South China. In China's fast-growing construction market BASF already operates admixture plants in East, North and West China. Mark Volmer, Group Vice President, responsible for BASF's Construction Chemicals business in Asia Pacific, said: "The acquisition is a strategic addition that strengthens BASF as the market leader in the Chinese construction chemicals

Previous admixture acquisitions took place in Beijing in 2005, Chengdu and Suzhou in 2006.
